It was determined in 2022 that an engine rebuild would cost approximately \$14,000 and the declaion was made to replace the truck. We were granted a 2-year extension from the state to bypase the emissions testing and could allif maister and plate the validle; the truck was to be replaced after the 2-year extension was up (2024). 509 was replaced with a used 2017 Ford F-250 quad cab. The cost of the Ford was approximately \$12k under the budgeted amount.
