I understand that no filing of disclosure reports is required unless and until the two hundred dollars (\$200.00) threshold has been met pursuant to Colorado Constitution Article XXVIII, Section 2(2), § 1-45-108(1) C.R.S., and the Secretary of State Rules Concerning Campaign & Political Finance, 8 CCR 1505-6. I affirm that I am/ am not (check one) a member of an Executive Board of a Unit Owners' Association, as defined in § 38-33.3-103, C.R.S., located within the boundaries of the District for which I am running for office.
