HEATHER GARDENS METROPOLITAN DISTRICT RECALL OF DANIEL TAYLOR

RECALL PETITION COMMITTEE STATEMENT:

Daniel Taylor, as president of the Heather Gardens Metropolitan District (HGMD) Board, publicly called the Chief Executive Officer and the Chief Financial Officer "insubordinate." He has made accusations of criminal behavior against them. He has made demands of Heather Gardens Association (HGA) and its employees, including removing their equipment from space that is being used, that were not authorized by the HGMD Board. He has demanded that an employee's work hours be expanded beyond the limits of the state labor laws. Since he took office, the Chief Executive Officer, the Chief Financial Officer, the Security Chief, the Clubhouse Manager, the Maintenance Manager, and the Resident Services Coordinator have resigned. He joined the other directors who are subjects of this action in resolving to terminate the management agreement between HGMD and HGA.

DANIEL TAYLOR STATEMENT:

We promised to restore committees. Under my leadership, we did. We promised to increase revenue to reduce the Rec Fee. We did. The restaurant has become the center for an active community forecast to increase revenue \$250,000 over 2023. The 2025 Rec Fee was reduced to less than \$62 per unit. Investments have been moved to an investment pool for increased earnings. We implemented standard contracts requiring bid, performance, payment, and warranty bonds. Our new accounting system will allow accurate, real-time, decision making for managers. We increased RV lot security, installed a new auditorium sound system, and the new flooring is on its way. The District Court ruled that we are entitled to the documents we requested from the HOA. The State Controller and the Special District Association have agreed that an HOA cannot commingle their money and the District's money in the same checking account. A vote not to recall will allow these reforms to continue. We'll turn our attention to the clubhouse in 2025. We are ready to increase classes, dances, events and trips. Minimum wage employees will receive increases based on their years of service. Volunteers will once again assist at the front desk. Employees will transfer to the District at their existing wages and benefits. Change is difficult for some. The recall committee wants to turn back time. Consider the rumors, fear mongering and character attacks as growing pains. Look past them. We have been transparent. Every meeting is recorded and on our website: HGmetroDist.org. This recall shouldn't be about personalities as stated by the recall committee. It should be about results. It's about improving the services to this community and minimizing the costs. I have stood my ground and argued to implement these reforms when necessary to represent the community's interests. Vote no to recall.
